8. No alcoholic beverages or selling of firearms allowed on Douglas County Fairgrounds property.
9. Vendors must stay at and attend their reserved space until 3:00 p.m.! No vehicle Loading is allowed prior to 3:00 p.m. on the last day of meet!
10. Parts Pick Up: No motor vehicles allowed in or out during public hours.
