- 3. Approved vehicles will have an assigned space given to them at the event.
- 4. Better Car Shows, LLC as the producer of the event has the final authority as to the location of all displays.
- 5. Better Car Shows, LLC reserves the right to refuse any entry that does not meet show standards.
- 6. When a vehicle and/or display is set up for the show, the vehicle and/or display cannot be removed until the end of the event without written permission of Better Car Shows, LLC.
- 7. Better Car Shows, LLC, Medford Rod & Custom Show, show judges, sponsors, show staff, volunteers, and their estates may not be held responsible for theft of, or damage to, vehicles on display at the event.
- 8. Exhibitor agrees to obtain insurance covering exhibitors vehicle, trailer, display, all belongings and medical. The exhibitor assumes full responsibility for any loss and/or damage.
- 9. Applications must be received 45 days before show. Better Car Shows, LLC is not responsible for any lost or late entry materials.
- 10. Exhibitor to provide 3/4 front, 3/4 rear, engine and interior photos with application. Application will not be considered without photos. Photos submitted become the property of Better Car Shows, LLC and may not be returned.
- 11. All vehicles will be set up with a drip pan and exhibitor agrees to be held liable for any automobile fluid leakages or stains that may occur from their vehicle and any damage to floor from vehicle.
- 12. The exhibitor, vehicle owner, spouses, relatives and guests agree to allow Better Car Shows, LLC the use of their names and photos for publicity, advertising and commercial purposes before, during and after the event without any compensation to the exhibitor or vehicle owner.
